A MESSAGE FROM OUR COMMANDER

This will be my last column as your Commander. Two years went by quickly. My first term was filled with a full schedule, but the second year was the Coronavirus one. We learned so many things from the shelter in place experience. First, we can connect with our computers. I used to do this at work to save having to travel across the country for meetings while still being able to view the same PowerPoint slides, Excel spreadsheets, Word documents, and Adobe Acrobat files. It is amazing how much work got done when linked up with project managers, other engineers, and marketing people spread across the world.

By comparison, I attended two District 20 conferences and one USPS National conference from the comfort of my home. Your Skokie Valley Executive Committee held regular meetings the first Wednesday of every month without missing a beat. We shared the agenda, minutes, treasurer's report, letters from National and District people, and other items to conduct regular business. I saved on paper because I did not have to print up anything to pass around as I did at the dinner meetings we used to have at Yen Yen restaurant in Buffalo Grove.

We had something new, namely two Happy Hour member meetings, the most recent one with a beautiful picture tour of the Great Loop hosted by our own Dick Hughes. Dick is in Florida, as were other attendees, but you could not tell. The speed of the Internet made it seem like we were all in the same place. Also, everyone had a front row seat for the slides.

As I mentioned several times in the past, this paradigm shift is not going away. It has been an honor and a privilege to serve Skokie Valley as your Commander. My best wishes to Tony Palazzo as he takes over command on April 24. I will be your Squadron Education Officer again. With these electronic tools being so commonplace, I hope to get more students in my classes.



New America's Boating Club Mobile App

The app has great features and useful information for a safe day on the water. Check the weather where ever you are, and use the File a Float Plan feature on the boat or even a long road trip. It's good to let someone know were you are going in the event of an emergency. Members and non members can use the app!!

- ⇒ My Location let your friends know where you are to meet up
- ⇒ Emergency quick reference information you learn in the class like radio call procedures, visual distress signals, and medical guidance.
- ⇒ File a Float Plan auto fills your information and makes it simple to email family or friends
- \Rightarrow Reference information
 - Glossary terms from the ABC course
 - Knots pictures and how to tie them
 - Weather links to the US National Weather Service (e.g., storm tracker)
 - Buoys how to recognize them on the water
 - Tide charts links to the NOAA website
 - Nautical flags alphabet and numbers
 - Navigation lights for different types of vessels (power, sail, fishing, etc.)
 - Navigation Rules quick reference
 - Learning Center, USPS courses and seminars, and America's Boating Channel all link to information found on the USPS website

OUR GREAT LAKES, OUR GREATEST RESOURCE

I recently saw an online article for Discover Magazine about prehistoric rock structures found underwater in the Great Lakes. A few months back I wrote about the stones found in Lake Michigan near Traverse Bay. They appeared to have prehistoric carvings, although they have not here wrified as the stones are active




they have not been verified as the stones are covered in algae and invasive mussels.

The new discovery is in our sister Lake Huron. Thought to be about 9000 years old, when the Great Lakes water level was much lower, the structure is 120' below water. It is a 300' hunting structure consisting of stone walls that could have been used to funnel migrating caribou along a path with multiple hunting blinds. Nearby the divers found numerous stone tools, rings used to stake down tents, and even campfire rings with well preserved charcoal remains. This is one of the largest manmade hunting structures found beneath the Great Lakes.

Recreational Boating Safety Statistics—2019 Executive Summary ~Submitted by Education Officer Jim Soyka, SN-CN

- In 2019, the Coast Guard counted 4,168 accidents that involved 613 deaths, 2,599 injuries and \$55 million dollars of damage to property as a result of recreational boating accidents.
- The fatality rate was 5.2 deaths per 100,000 registered recreational vessels. This rate represents a 1.9% decrease from the 2018 fatality rate of 5.3 deaths.
- Compared to 2018, the number of accidents increased 0.6%, the number of deaths decreased 3.2%, and the number of injuries increased 1.9%.
- Where cause of death was known, 79% of fatal boating accident victims drowned. Of those drowning victims with reported life jacket usage, 86% were not wearing a life jacket.
- Where length was known, eight out of every ten boaters who drowned were using vessels less than 21 feet.
- Alcohol use is the leading known contributing factor in fatal boating accidents; where the primary cause was known, it was listed as the leading factor in 23% of deaths.
- Where safety instruction was known, 70% of deaths occurred on boats where the operator did not receive boating safety instruction. Only 20% of deaths occurred on vessels where the operator had received a nationally approved boating safety education certificate.
- The top five contributing factors in accidents were: operator inattention, improper lookout, operator inexperience, excessive speed, and alcohol use.
- There were 171 accidents in which at least one person was struck by a propeller. These accidents resulted in 35 deaths and 155 injuries.
- The most common vessel types involved in reported accidents were open motorboats (45%), personal watercraft (19%) and cabin motorboats (16%). The vessel types with the highest percentage of deaths were open motorboats (48%), kay-aks (14%), and personal watercraft (8%).
- The number of registered recreational vessels in 2019 was 11,878,542, which represents a 0.22% increase from 2018.
