A MESSAGE FROM OUR COMMANDER

h, the transition from meetings to boating is finally here. Our programs shift into summer mode. The best example was a cruise we took to Door County, WI last week. There were seven boats when it was planned, and one when it was time to get underway. Some of us had conflicts that came out of nowhere, two had medical situations to handle, and the inevitable hell (fog) and high water (big waves) issues showed up. The destination was Sturgeon Bay. Ron and Joanne Zingler piloted their 42 foot Carver, *Gotta Love It*, after a two day delay to Center Pointe Marina. It was done in one day, with a refueling stop in Sheboygan, 160 miles, all in about 10 hours. When they arrived, four of us were on the dock to help them tie up.

Naturally, we wasted no time opening the bar on Ron and Joanne's party barge. Those four landlubbers were Don and Gail Sidman, Bonni Breen, and yours truly. We had dinner at the Fish Creek home of Keith and Kathy Parker. It was a wonderful experience. We toured their lovely cabin (two story) in the woods, including a garage with a nice workshop, screen porch, gorgeous decoration throughout, and more comforts than many of us have in our primary homes. Dinner was a memorable buffet of chicken, pasta, salad, other sides, and the dessert was a cherry pie from the locally grown crop that Door County is famous for. A week earlier, Bay Marine had a flare shoot that our squadron organized. Jim Soyka brought most of the ordnance and gave the safety lecture. The rest of the open house was a pair of lectures on the Great Loop and the North Channel. At the end of June, we taught another ABC class at Sequoit Harbor. Pat Antoni, Joe Paldo, and I did the whole process in one day. It was exhausting, but most students want a fast and painless class where they can walk out with a certificate the same day. This format seems to work, so another ABC class will be offered at Bay Marine on September 28. Tell anyone you know that might want a starter class.

Finally, August will start out with a bang. The Tall Ships will arrive at Southport Marina, my boat will help escort them, our members will help District 20 run the event, and the Cruise & Rendezvous will take place there.

An informal dinner is planned at Hob Nob in Racine. That is a fine restaurant with a bar to remember, situated on a beautiful stretch of Lake Michigan. It is worth the trip. Many of us have been there before, and we want to go back again.

This is another lighthouse George saw when he was with Dick & Dorothy Hughes on their last leg of the Great Circle from Ft. Myers, FL to Waukegan, IL. George took this picture from the boat.

You get to the lighthouse from hiking trails in Killarney Provincial Park. This area is quite beautiful with sapphire blue lakes and white quartz ridges. The area has always been a popular destination for artists. The park only has one campground to keep the area a place of solitude and beauty in an undisturbed natural setting.

A contract was put together in 1850 to cover the cost of building four lighthouses on the north channel that run between the northern end of Georgian Bay and Lake Superior, but the cost became too high and led to postponement of north channel lights.


Finally in 1866, the government built five nearly identical lights. The Killarney lights were originally called Red Rock Light and Partridge Island. They were both built on bare rock. They are now called Killarney East and Killarney Northeast. They were both taken care of by one light keeper who would travel between the two by boat. Those early lighthouses did not offer housing for the light keeper, so he had to build himself a shack to live in.



Killarney East Lighthouse Killarney, Georgian Bay, Canada 46° 5′ 0″ N, 81° 20′ 0″ W

The present lighthouses built in 1909 are square, tapered towers mounted with octagonal iron lantern rooms. A hand foghorn was used at the East Lighthouse until 1957 when a fog whistle was installed. Traveling from the East Lighthouse to the Northeast light was very dangerous. Keeper Solomon's (1950-1960) boat capsized when he drew near the East Lighthouse. Before the boat turned over, Solomon grabbed two lifejackets and used them to stay afloat as he was repeatedly washed by waves. Eventually the icy water took away his strength, but just when he was giving up hope, a large wave pushed him onto a large shoal. The local game warden braved the waters and rescued Solomon who made a full recovery and looked after the lights till 1960 when he died at the age of fifty-nine.

Is Paradise Gone?

California was one of the places where everyone thought was perfect. It had the pleasant weather, scenic views, close to the ocean and so much more.

What California did not have was an abundance of water. As more people chose to live in California, the more congested roads became. The roads in the hills and mountains were windy and steep. Then climate added its own touch to the weather. It withheld rain making much of the wooded countryside dry and the Santa Ana winds did not help if a wildfire started.

Firefighters have never stopped a wildfire powered by Santa Ana winds. Wildfires can travel at 60 mph and they will consume everything in their path. This past year the Woolsey fire destroyed an entire town of 26,000 in 12 hours and the only thing that could stop it was the Pacific Ocean. But while this fire was burning, a fire further North called the Camp Fire was burning simultaneously, which was just as destructive.

Some California Residents are beginning to wonder if this area is really inhabitable by large amounts of people. Most of us want to live in an area with ideal weather that is affordable. Unfortunately based on what we know about this area of our country, the lack of rain, the dry conditions, the occasional mud slides, the earthquakes...makes one think, is California the paradise many of us thought it was.

Speaking of paving paradise, I just read an article in the Milwaukee Journal Sentinel about four schools in the Milwaukee area that are doing just the opposite. 


The project is being led by the Green Healthier Schools Program, which advocates for environmental education and sustainability. It gives the kids access to nature and increases academic performance. The hands-on learning opportunities in the gardens and outdoor classrooms improve understanding of topics like plants, gardening and photosynthesis. They also plan to make the space open to the community afterschool, so kids have a safe place to play.

According to the program, the organization works with five schools each year to develop their green space. So every year, schools in Milwaukee are at different stages from fundraising, design, permitting, construction and maintenance. So far two schools have completed the program, four are in construction this year, and five more are doing fundraising for next year. Each project takes about three years to complete.

North Point Fishing Derby

I love my daughter. I am also a sucker for her. So, when she said, "Dad, I would be up for fishing with you," I bought it, hook, line, and sinker. My daughter, the imp that she is, did not realize the extent to which these forthright members of the Power Squadron, as well as myself had been suckered into her net. The day of course had just begun. The crew from *The Tropics* then hung around and attended the Sun Downer. It was a long but wonderful day. All of us from the *Son Set* agreed that bad day fishing was better than a good day at work.
