




YOUR WEATHER REPORT By Mike Hennessy, AP, Instructor-Weather course

Snow

Snow comprises individual ice crystals that grow while suspended in the atmosphere—usually within clouds—and then fall, accumulating on the ground where they undergo further changes. It consists of frozen crystalline water throughout its life cycle. Under suitable conditions, the ice crystals start to form in the atmosphere, increase to millimeter size, precipitate and accumulate on surfaces. Then they metamorphose in place, and ultimately melt, slide or sublimate away.



by attracting supercooled water droplets, which freeze in hexagonal-shaped crystals. Snowflakes take on a variety of shapes, basic among these are platelets, needles, columns and rime.

Snowstorms organize and develop by feeding on sources of atmospheric moisture and cold air. As snow accumulates into a snowpack, it may blow into drifts. Over time, accumulated snow metamorphoses, by sintering, sublimation and freeze-thaw.

Where the climate is cold enough for year-to-year accumulation, a glacier may form. Thank goodness we don't live there! Fortunately for us, snow typically melts seasonally, causing runoff into streams and rivers and recharging groundwater.

OUR GREAT LAKES, OUR GREATEST RESOURCE


Snow in the Great Lakes region is classified as lake-effect snow and non-lake-effect snow. Lake-effect snow occurs due to increased precipitation, as storms pass over the lakes and gather more moisture in the air. The areas most impacted by the lake-effect snow are downwind, which is why often Indiana and Michigan get much more snowfall than Chicago.

Recently snow in the Great Lakes region has been changing. Snowstorms impacting the region have been decreasing, but around the lakes there is more snow during storms. Also, warmer weather fluctuations tend to melt the snow in between storms, so there is less snow coverage over winter. This also contributes to earlier snowmelt in the spring.

There is evidence that lake-effect snow is increasing around Lake Michigan and Superior and the areas that are impacted by lake-effect snow are growing. The decreasing ice coverage on the lakes plays a major role in this because lake-effect snow only occurs when the lakes are not completely frozen over. As the air temperatures increase, so does the lake temperature, which increases the surface area creating more precipitation.

It's located in the Hammond Harbor Basin of Lake Michigan, just 12 nautical miles from down-town Chicago, and features recycling bins throughout the marina as well as a top-notch drainage system and boat wash-down station that keeps dirty water from flowing into the lake. Beyond the cleanliness of the marina, it's also fuel prices that attract customers. Anyone who boats in or around Chicago knows that gas



prices are a bit higher than, say, in Indiana. Since Hammond Marina is located on the state line of Illinois and Indiana, it's able to offer Indiana fuel prices at a lower rate. Add into the mix the marina's extended hours and location, and it makes the perfect stop for boaters.
