

YOUR WEATHER REPORT

Winter Weather Hazards

The colder air temperatures in the winter result in an increase in air density. Consequently, for a given wind speed there is greater physical discomfort and higher, more violent waves. The winds are much stronger and squalls and storms more frequent.

On inland waters there are special winter hazards. A cold spell can reduce the flow of a river; thaws can quickly increase river flows and floating hazards. Lakes may be drawn down in anticipation of thaw flooding. Debris laden water can deposit its load as rushing water enters into a still lake forming new gravel bars.

Snow and ice on slippery surfaces increase the risk of falling. Snow restricts visibility more than rain and makes obstacles appear farther away.

Winter conditions directly affect our bodies and senses. People who are cold are less vigilant because the senses are dulled. Survival time in the cold is reduced; exposure in cold air leads more quickly to dehydration; and a combination of wind and cold can result in frost bite and hypothermia from heat loss.



OUR GREAT LAKES, OUR GREATEST RESOURCE

Cigarette butts continue to rank among the most common types of marine debris found. The Ocean Conservancy's 2018 International Cleanup Report stated 2,412,151 cigarette butts were collected worldwide in 2017. That is a huge increase from the 1.86 million collected in 2016. Every year cigarette butts




are the number one most collected item during the cleanup efforts; sometimes 25% of the litter collected. Sadly the majority of the public are unaware the problem is so pervasive.

Most cigarette filters are made out of cellulose acetate, a plastic like material that does not degrade easily. The fibers in cigarette filters behave like plastics in our waters. The UV rays from the sun break the fibers down into smaller pieces, but they don't disappear. One solid filter ends up being thousands of tiny microplastics that are released into the marine environment.

A study from San Diego State University suggests one smoked cigarette butt in a single liter of water is sufficient to kill marine and freshwater fish, although how this translates from the laboratory to the environment is unclear. We do know other forms of microplastics and microfibers in our waters pose a risk to marine organisms and the water we consume every day.



Cape Fisterra Lighthouse (Faro de Cabo Finisterre)

The thing I remember the most about this lighthouse was that it had an Art Gallery on the 1st floor. It is a part of a permanent collection of photographs done by one of the light keepers, but I could not find anything online about this Gallery.

The famed lighthouse at the end of the world, Faro de Fisterra, is one of the most recognized landmarks in all of Galicia. The lighthouse was built in 1853, and on a clear day, can be seen from 19 miles out at sea.

The northwest coastline of Galicia is rough, jagged, and treacherous. Therefore, it was given the appropriate name, Costa da Morte, the Coast of Death. Numerous vessels from ancient times to the present are resting on the floor of the Atlantic with lives lost multiplied many times more. It's not only pleasure and fishing boats that have had distress, but well-documented naval battles between the French and English occurred just off Cabo Fisterra. Because this prominent landfall is between Northern Europe and the Mediterranean, there have been many battles to try to control the area. Visitors are also reminded to be careful walking on the slippery rocks as deaths on the coastline around the lighthouse have also occurred.

Because of the ancient belief that Fisterra was the end of the world, there are special spiritual & physical significance to this site. Galicia, Spain 42.882362°N 9.271849°W




There was a pit where people could burn their clothes; they would leave worn boots, and build stick crosses. This is not allowed any more and the area has been cleaned up. Because pilgrims used to walk here from their walk of *the Way of St. James* to the Cathedral of Santiago, it is just another 56 miles to the end of the world. These pilgrims are the ones that burnt their clothes or boots at the end of their journey.


