On Monday morning we depart from Sturgeon Bay and head to Harbor number 2 in Menominee Michigan where we will stay at the Menominee Marina.

In historic times, this area was the traditional territory of the Menominee Indian Tribe. The town of Menominee was named after their English name, which roughly translates as "wild rice," a nickname given to them by their Ojibwe neighbors based on their cultivation of wild rice as a staple food. In their own language, they are known as *Mamaceqtaw*, which means simply "the people", and the town of Menominee is known as *Menikāneh*, which means "at the good village". They were removed to the west of the Mississippi River and now have a reservation along the Wolf River in North Central Wisconsin after ceding their territory to the United States in the 1836 Treaty of the Cedars.

Menominee gained prominence in the 19th century as a lumber town; in its heyday, it produced more lumber than any other city in the United States of America. During this time of prosperity, the House was built. It is being restored now. In the 1910s a cycle car, the "Dudly Bug", was manufactured in Menominee. In the waning years of lumber production, local business interests, interested in diversifying Menominee's manufacturing base, attracted inventor Marshall Burns Lloyd and his Minneapolis Company Lloyd Manufacturing, which made wicker baby buggies. In 1917 Lloyd invented an automated process for weaving wicker and manufactured it as the Lloyd Loom. This machine process is still in use today. In the 21st century, the economy of Menominee is based on manufacturing paper products, wicker lawn furniture, auto supplies and tourism.

In 1940, during the "Vote for Gracie" publicity stunt in which comedian Gracie Allen ran for President, she was nominated for mayor of Menominee, but was disqualified because she was not a resident of the city.

Menominee Marina is a full service very large Marina that can handle boats from 25 feet to 60 feet. There is Boaters Lounge, Free Wi-Fi, and Courtesy Bicycles. Looks like a great place to stay. Next Stop Kewaunee Wisconsin, Salmon Harbor Marina. <https://www.salmonharbor.net/>

**Salmon Harbor Marina** was developed late Dec. 2005 by members of the Lamer family who originally started the Marina over 15 years ago. It is nestled just off of Hwy 42 north of the Kewaunee River Bridge in the heart of Kewaunee. The Lamar's expanded the marina from just the docks, to a full service marina.

This is one of Wisconsin's most naturally protected harbors and they offer outside and inside storage, a full mechanics shop, ship's store, fuel, lounges, and camping. They have a great staff of highly qualified individuals to help to serve our needs, and are looking forward to a great boating season.



## **YOUR WEATHER REPORT**

### **Flooding**

Every spring there is flooding in the USA. Usually the flooding is associated with the Red River, the Mississippi, or the Missouri Rivers. Then of course there is the local flooding that we see in the Des Plaines River and the Fox River.

This year we had the flooding but the areas that were hit were different. The Arkansas River was the main culprit this year causing severe flooding in Arkansas, Missouri and Oklahoma.

Although some areas were not flooded by rivers, the excessive rain did not allow farmers to plant their crops because their fields were too muddy. Even the Chicago area has experienced the wettest May in our history.

Because so many areas that have been flooded this spring (even areas that never flood) the government is preparing new flood zone maps. This will help people decide if they should include flood insurance in their insurance planning.

Many are asking why this Spring was so wet, and I have not seen any conclusive answer. But if wetter Springs are in our future, then many things are going to change. More and stronger levies, probably less crop production and probably higher insurance rates.

Let's hope Spring 2019 is the exception and not the new normal.



### **OUR GREAT LAKES, OUR GREATEST RESOURCE**

Freshwater ecosystems are among the most threatened habitats on earth. In the US, these include rivers, streams, lakes, wetlands and of course, our Great Lakes. Many fish and aquatic species that depend on freshwater face critical challenges to their survival.

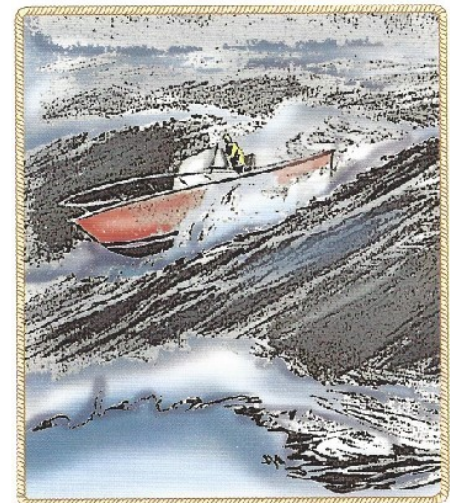


The National Fish and Wildlife Foundation has been focusing on freshwater conservation issues for over 25 years. The organization supports conservation programs to protect and sustain major river, stream and aquatic ecosystems.

The NFWF has several approaches to restore and maintain freshwater species and their habitats.

- \* Passage: eliminate barriers to fish movement.
- \* Water quality: reduce pollution to restore clean water.
- \* Water quantity: ensure stream flows are maintained at healthy levels.
- \* Spring systems: protect springs and other unique ecosystems for freshwater species.
- \* Control invasive species: restore the natural balance of the ecosystem.

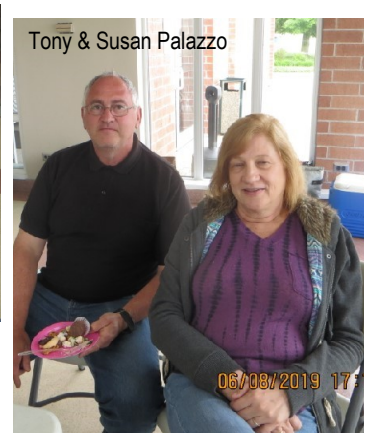

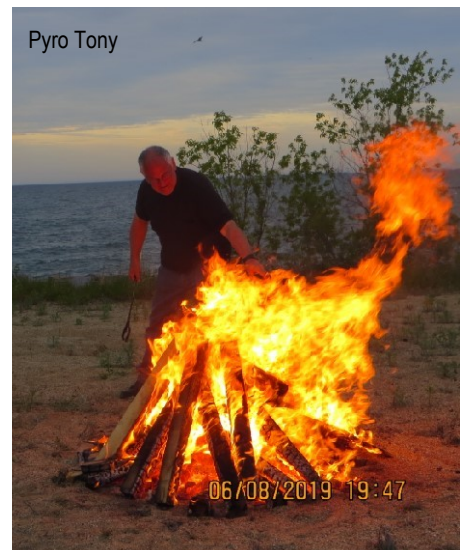

## Strawberry Island Lighthouse Georgian Bay, Ontario Canada

George took this picture from Dick & Dorothy's boat when they were on the last leg of a Great Circle trip. George had joined them in Detroit as they made their way to Waukegan.

This lighthouse is an important beacon for those traveling through Georgian Bay and Lake Superior, which is an intricate channel that winds between numerous islands. This lighthouse lies just west of the northernmost section of Manitoulin Island and the town of Little Current. Little Current is the largest in the area, and is also the administrative Centre.

Because of the importance of this location, a lighthouse was built on the island in September 1881. It had a fixed catoptric at an elevation of 40 feet above water mark and would be visible 11 miles from all points seaward. The building consists of a square wooden tower, 44 feet high with a keepers dwelling attached.

The longest-serving keeper of Strawberry Island was William McKenzie. He and his wife and children would cross over to the Island in March on a sleigh before the ice melted and leave in October. No need for a lighthouse keeper if the bay is frozen over.

In June of 1915, the white fixed light was improved with a fourth-order lens for the lamp and reflector that had been formerly used in the lantern room.

In 2006, Strawberry Island Lighthouse was declared a Recognized Federal Heritage Building, most of the recognition had to do with the beauty and ascetics of the lighthouse. The lighthouse can only be accessed by boat. SVPS can get to it on their next trip to the North Channel.
